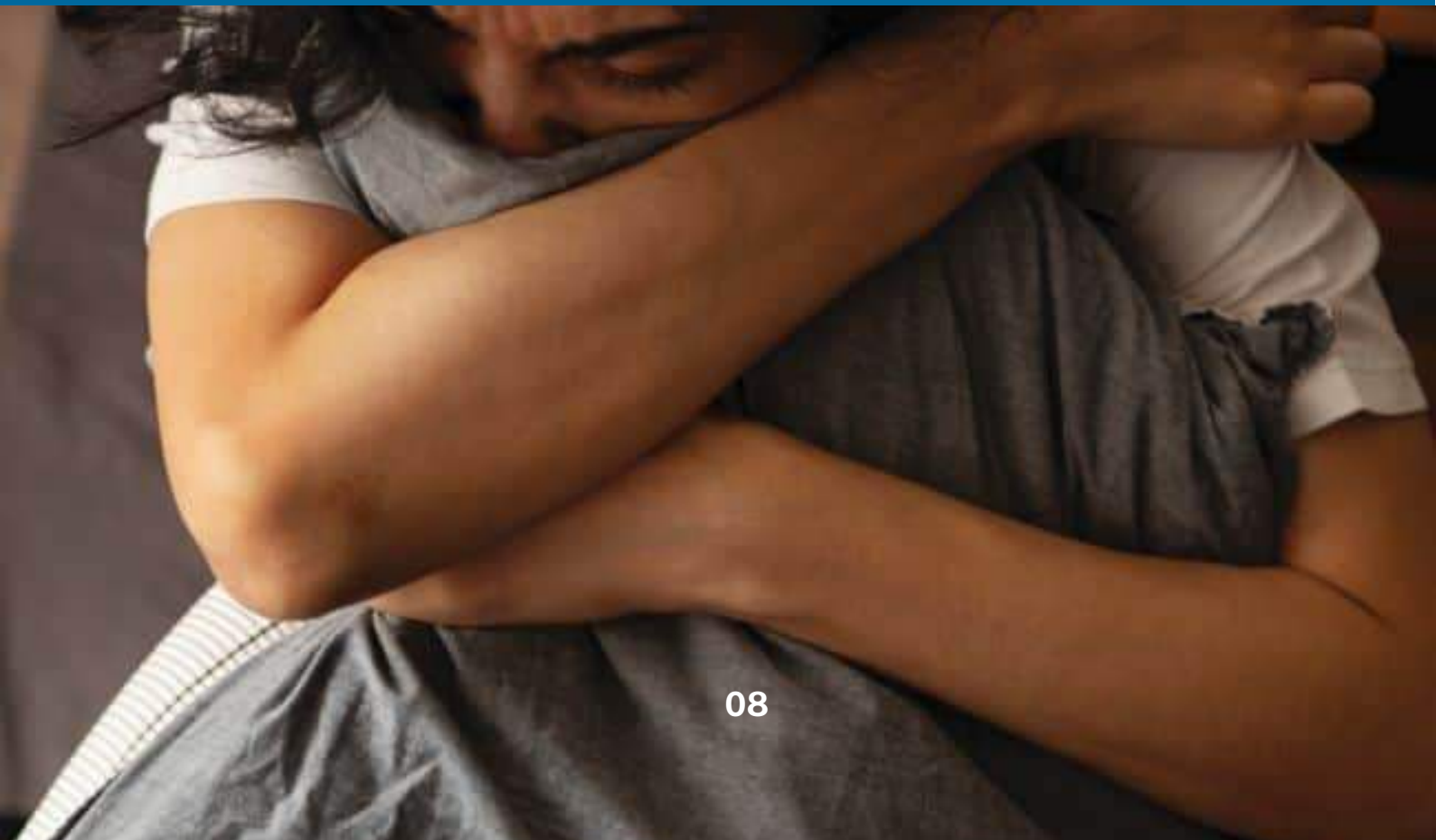
Anti-Bribery and Anti-Corruption Policy

Mental Health and Social Challenges



A research article titled “Stepping Back from the Ledge: Motivations and Restraints” by Associate Professor Dr. Anasuya Jegathevi Jegathesan from the University of Cyberjaya explored the lived experiences of suicide survivors in Malaysia. The study examined the psychological and social factors influencing suicidal behavior, including internal emotional distress, crisis events, and anticipatory hopelessness.

The findings highlight the importance of community intervention and public awareness to prevent self-harm and social tragedies, which are increasingly relevant to understanding the broader dimensions of social issues and deviant behavior within Malaysian society.
